#### **FAQs**

### What previous business experience is required to apply?

No business experience is required to apply to any of the programs. In fact, we would expect most candidates to have no prior experience.

#### As I'm new to consulting, will I receive training before the program starts?

Each program begins with intensive training on core consulting skills specifically aimed at individuals with no consulting background. Specific length of training will vary by program.

While I enjoyed and learned a lot during my four years practicing law, the switch to BCG has been the best career move I could have made. The training, breadth of work, client exposure, and diversity of intellectual backgrounds makes it the kind of dynamic work environment I was looking for when I left the law.

## What kind of work will I be staffed on during my time at BCG?

As with any of its Consultants, BCG will do its best to match individual preferences with the needs of the business to find suitable staffing placements. Over time, BCG Consultants experience a wide variety of industries and functional areas—area-specific expertise is not expected until later in a BCG career.

## What is required as part of the application?

All programs require: (1) a 1-page business style resume which includes undergraduate GPA, graduate GPA if applicable, and graduate test scores (GRE, LSAT, MCAT and boards, etc.) and (2) responses to essay questions on the application.

#### Will I use my legal background at BCG?

While you will not be practicing law at BCG, the critical thinking and reasoning skills central to a legal education are greatly valued. Additionally, work in the public sector, regulation, and M&A are particularly well-suited for those with a legal background. BCG also strongly encourages newly-hired JDs to take the bar exam, reimbursing them for a bar exam preparatory course, the exam fee itself, as well as the registration fees in the state in which the exam is passed.

#### Is the recruiting timeline the same as for law firms?

For those able to start before March 2019, applications are accepted on a rolling basis from now until March 2019. Interviews are in a BCG office, rather than on-campus, and there are two rounds of interviews.

#### How much client interaction will I receive as a new Consultant?

Consultants receive ample client exposure very early on in their tenure, regardless of background. It is not uncommon for Consultants in their first year to interact directly with CEOs of Fortune 500 companies.

#### Are there opportunities within public service at BCG?

Many BCGers work with public sector and non-profit clients, sometimes as full-time projects, other times as "side projects" in addition to their primary casework. Some of our non-profit clients include The Bill & Melinda Gates Foundation, The World Wildlife Fund, and Teach for All. Our public sector clients include, federal, state, and municipal governments across the country.
